Municipal Taxes

There are four tax installments each year. Bills are mailed twice a year. The interim bill shows the amounts owing for the first two installments (February 29th and May 31st) and the final bill shows the amount owing for the last two installments (September and November). The interim bill is based on 50% of 2023 total taxes billed. The final bill is based on your 2024 assessment multiplied by the approved 2024 tax rate.

Tax notices for all properties are mailed at the same time, regardless of whether a mortgage company or individuals pay them. If your mortgage company pays your taxes, the tax notice you receive will show the name of the company and a mortgage number on the bill.

Payment Options

Ensure payments for ANY amounts owing to the Municipality are received in office by the due date to avoid late penalties.

If making branch, telephone, or internet payments for taxes, utilities, etc., please allow for processing time (up to three business days).

When paying your property taxes through online banking, use the 15-digit roll number found on your bill without the dashes. Please do not use 4020 digits found on the MPAC Assessment Notice.

Important dates in 2024

Mark these important dates on your calendar for the coming year:

- Tax due dates: February 29th, May 31st, September (TBA), November (TBA).
- Utility rates (water) increase starting January 1st (By-law 43-2021) and are shown on the April bill. Payments are due January 31st, April 30th, July 31st, and October 31st.
- Dog tag renewal deadline: February 28th
- Spring watermain flushing dates will be posted on the municipal website closer to the date.
- Development charges change in 2024. See our website for the most current rates.

Agricorp-Farm tax program

The Government of Ontario supports agriculture through the Farm Property Class Tax Rate Program, also known as the "Farm Tax Program." Your property must be assessed as farmland and placed in the Farm Property Tax Class Rate Program by Agricorp. For more information, visit <u>https://bit.ly/3DGhZ84</u>.

Any 2024 pending farmland tax incentive adjustments will be processed after the 2024 final tax levy has been processed.

Supplementary/omitted tax bill

A supplementary and/or omitted tax bill results from updated assessment information recently provided to the Municipality by the Municipal Property Assessment Corporation (MPAC). Residents receive property assessment change notices from MPAC. These notices are issued when the current value assessment or the tax classification of your property has changed due to approved reasons. If you disagree with the supplementary and/or omitted assessment, you must file a Request for Reconsideration (RfR) with MPAC within the time mentioned on the Property Assessment Change Notice.

Utility Reminders

Contact the Utilities Clerk if you have used water during a billing period but the water usage on your bill is zero. It means a water meter reading was not obtained.

If you are moving, please schedule a final meter reading with us. A forwarding address for the final bill needs to be provided.

Appointments are required for water turn-ons. Seasonal water turn-on appointments will be booked on Tuesdays. Only the municipal operator acting on municipal staff's direction or authority may operate the curbstop.
